ORDER GRANTING SECOND SUPPLEMENT TO APPLICATION FOR APPROVAL OF FEES AND EXPENSES

On this date, the Court heard the *Second Supplement to Application for Approval of Fees and Expenses* (the “Application”) filed by CANTILO & BENNETT, L.L.P., Special Deputy Receiver of Access Insurance Company (the “SDR” and “AIC” respectively).

In accordance with the *Order of Reference to Master* (“Order of Reference”), the Application was submitted to the Special Master appointed in this proceeding. The Special Master has issued a report pursuant to Rule 171 of the Texas Rules of Civil Procedure, which is incorporated herein, finding and recommending as follows:

1. The Court has jurisdiction over the Application and the parties affected hereunder;
2. The Order of Reference provides that motions filed pursuant to TEX. INS. CODE § 443.015 are referred to the Special Master appointed in this proceeding;
3. Notice of the Application was provided in accordance with TEX. INS. CODE § 443.007 (d) and the Order of Reference;
4. No objections to the Application were filed;
5. The Texas Property and Casualty Insurance Guaranty Association filed an acknowledgement and waiver of the Application; and
6. The SDR’s Application should be granted in all respects.

Based on the Application, the evidence presented, and the recommendation of the Master, the Court finds that the Application should be granted.


IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED as follows:
