**SPECIAL DEPUTY RECEIVER'S APPLICATION FOR
APPROVAL OF FIRST REPORT OF CLAIMS**

TO THE HONORABLE JUDGE OF SAID COURT:

CANTILO & BENNETT, L.L.P., solely in its capacity as Special Deputy Receiver of Access Insurance Company (the "SDR" and "AIC," respectively) files this Application for Approval of the First Report of Claims (the "Application").

I. INTRODUCTION

1.1 The SDR files this Application to obtain approval of its first report of claims settled or determined under TEX. INS. CODE § 443.253.

II. AUTHORITY

2.1 On March 13, 2018, the Court entered an *Agreed Order Appointing Liquidator, Permanent Injunction, and Notice of Automatic Stay* (the "Liquidation Order") appointing the Texas Commissioner of Insurance as Liquidator of AIC. Effective March 13, 2018, the Texas Commissioner of Insurance, as Liquidator, appointed CANTILO & BENNETT, L.L.P. as Special Deputy Receiver of AIC. The SDR is authorized to file this Application pursuant to TEX. INS. CODE § 443.258.

2.2 On March 25, 2019, the Receivership Court entered its *Order Granting Special Deputy Receiver's Application for Approval of Claims Filing Deadline, Guidelines for Providing*

Notice, and Procedures for Processing Claims (the “POC Order”). The order established September 13, 2019 as the deadline to file POCs and authorized the SDR to deem all subrogation claims as timely filed.

2.3 This Court has jurisdiction over the subject matter of this Application and the parties herein pursuant to TEX. INS. CODE § 443.005. The Court has exclusive jurisdiction over property of the estate pursuant to TEX. INS. CODE § 443.005(c) and personal jurisdiction over all parties affected herein because this is a civil proceeding arising under and related to a delinquency proceeding under the Texas Insurer Receivership Act, Chapter 443 of the Texas Insurance Code.

2.4 Travis County is the mandatory, sole, and exclusive venue for this proceeding. TEX. INS. CODE § 443.005.

2.5 The subject matter of this Application has been referred to the Special Master appointed in this proceeding in accordance with Paragraph III of the *Order of Reference to Master*.

III. FIRST REPORT OF CLAIMS

3.1 TEX. INS. CODE § 443.258 provides that the SDR shall, from time to time, present to the receivership court a report of claims settled or determined by the SDR under TEX. INS. CODE § 443.253. Attached as Exhibit A is a report of all Proofs of Claim (“POCs”) filed against AIC, which have been determined as of December 31, 2020, by the SDR pursuant to TEX. INS. CODE § 443.253. Exhibit A identifies the claimant¹ and/or the POC number, the classification of the POC, and the amount allowed or other action taken on the POC. No written objections to the SDR’s determinations of these POCs were submitted under TEX. INS. CODE § 443.253(c) or, if any objection was filed, it has been resolved; therefore, the determinations are now final. The SDR

submits Exhibit A as its First Report of Claims and requests the Court approve its actions on these POCs pursuant to TEX. INS. CODE § 443.258.

3.2 The SDR has not completed the processing of all POCs and anticipates filing one or more additional Reports of Claims in the future.

IV. NOTICE

4.1 Pursuant to TEX. INS. CODE § 443.007(d), this Application has been served on the entire service list for this proceeding, including applicable guaranty associations, in the manner shown on the Certificate of Service.

V. OFFER OF PROOF AND VERIFICATION

5.1 This Application is verified by the affidavit and certification pursuant to TEX. INS. CODE § 443.017(b) of Susan E. Salch, designated representative of CANTILO & BENNETT, L.L.P., solely in its capacity as Special Deputy Receiver of Access Insurance Company.

VI. NOTICE OF ELECTRONIC SERVICE REQUIREMENT

6.1 All pleadings filed in response to this Application shall be served by e-mail on the undersigned counsel and all parties shown in the attached Certificate of Service.

PRAYER

WHEREFORE PREMISES CONSIDERED, CANTILO & BENNETT, L.L.P., solely in its capacity as Special Deputy Receiver of Access Insurance Company respectfully requests this Court to set a hearing on the Application and upon such hearing,

1. Grant the Application;
2. Approve the SDR's First Report of Claims; and
3. Grant the SDR such further relief to which it may show itself to be justly entitled.
